# WHAT ARE THE FAIM CRITERIA?

The primary objective of FAIM is to provide a worldwide common standard for managing and performing international relocation services in a uniformed, quality minded and effective way.

The FAIM Standard covers a series of requirements which all FAIM certified companies need to comply with at all times.

These requirements are updated regularly and cover areas like:

#### **✓ CONSISTENT QUALITY OF SERVICE**

All FAIM certified companies are audited on their **operational services and quality procedure,** making sure all work according to the same high level of quality, all the time.

#### **✓ SUPPLY CHAIN PERFORMANCE**

FAIM certified companies have to prove that they work with suppliers who follow the same high standards, leading to **better control of the entire relocation process.** 

#### **✓ FINANCIAL STABILITY**

To ensure the financial health of all FIDI Affiliates, each company has to provide specific financial information, which is **checked by an independent auditor on a yearly basis.** 

### ✓ COMPLIANCE WITH INDUSTRY STANDARDS & INTERNATIONAL REGULATIONS

FAIM certified companies are compliant with FIDI's strict **Anti-Bribery and Corruption charter (ABC)** and **Anti-Trust Charter (ATC)**, as well as **data protection principles** and relevant international compliance regulations.




# HOW ARE FAIM CERTIFIED RELOCATION COMPANIES AUDITED?

The FAIM certification programme is based on the FAIM Standard, which is regularly updated to reflect changes in the global mobility world.

The FAIM compliance procedure follows a cycle, with an extensive third-party audit every 3 years. This audit process is performed by independent auditors, currently EY.





### WHY TRANSPACK ARGENTINA?

Being FAIM certified is a big achievement for all FIDI Affiliates, but it is even a greater achievement to be certified as a FAIM Top Performer.

As a top performer, *TRANSPACK ARGENTINA* has scored at the end of audit day, O NCV (Non-Compliant Values) used as measurement indicators for the current standard FAIM 2022 which represents a total of 1475 NCV.
